


Basic Requirements for Filing Industrial Design in Malaysia

- i. A photocopy of Certificate of Incorporation [Forms 49 & 9] /Business of Registration [Borang A & D] (Corporate Information) (if the Applicant is an incorporated company/multiple partner, sole-proprietorship respectively); a photocopy of Identity Card or Passport (if the applicant is an individual or foreigner)
- ii. Please enclose the drawings or photographs (in 3D solid line drawing without measurement, with high resolution, grayscale, clear/white background) which illustrates at least 6 different views (eg: top view, bottom view, front view, rear view, side view, perspective view). Please refer to the below example:-



Example:- Perspective View for Juicer
